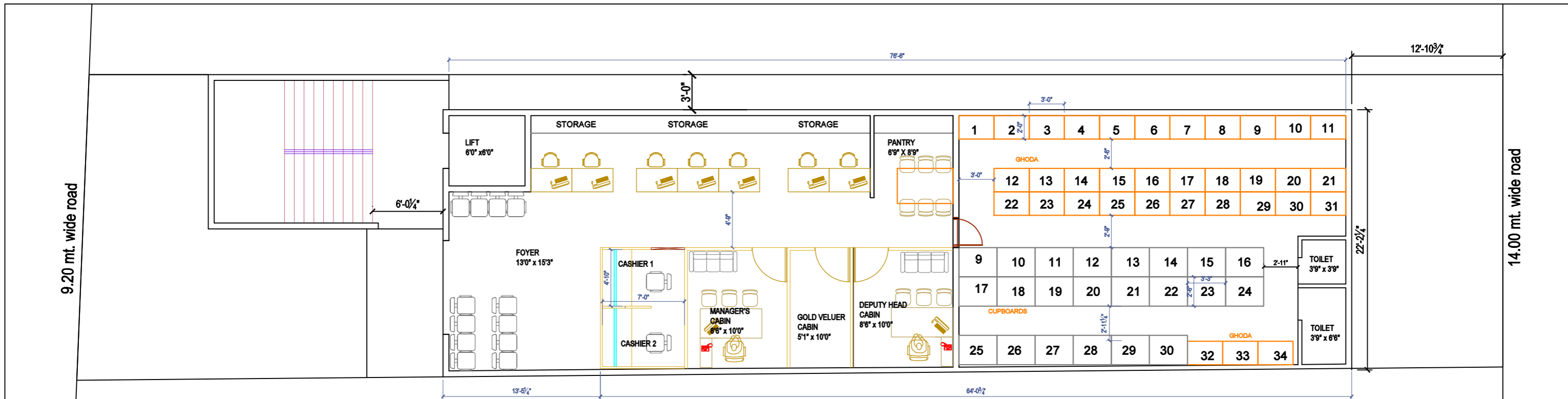

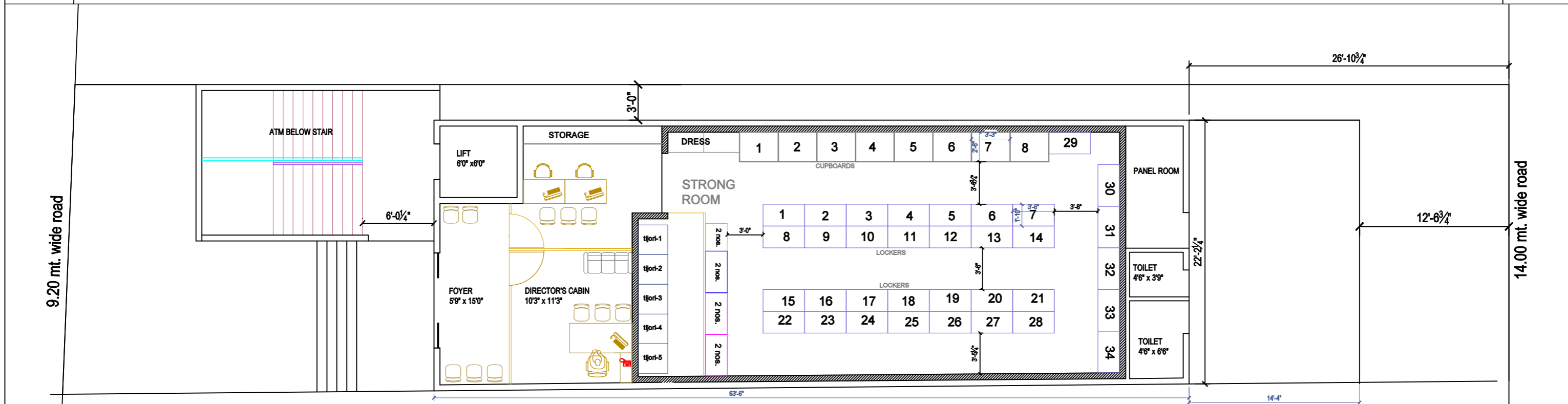

The contractor shall execute the work as per approved drawings, specifications, dimensions, site conditions, and instructions of the bank/consultant.

2. NAME OF WORK

4. SCOPE OF WORK

The scope of work shall broadly include but not be limited to:

Furniture Works

- Staff working desks.
- Cabin desks.
- Cash counters.
- Manager tables.
- Storage cabinets.
- File storage units.
- Customer waiting chairs.
- Executive chairs.
- Visitor chairs.
- Sofas and center tables.
- Reception/help desk.
- Side credenzas.
- ATM utility furniture.
- Modular storage units.
- Necessary hardware and fittings.
- Transportation, unloading, shifting, installation, and leveling.

Contractor's Responsibility

- Site measurements before execution.
- Preparation of shop drawings.
- Sample approval before manufacturing.
- Coordination with electrical/ civil/ interior agencies.
- Protection of finished surfaces.
- Proper alignment and finishing.
- Cleaning after installation.

5. MATERIAL SPECIFICATIONS

General Specifications

Unless otherwise specified, all modular furniture shall be manufactured using the following standards:

Core Material

- 19mm Commercial Ply / HDHMR Board for horizontal members.
- 16mm Commercial Ply / HDHMR for shutters and vertical members.
- 6mm Back panel.

Finish

- 1.0 mm laminate finish on external surfaces.
- 0.8 mm laminate finish on internal surfaces.
- PVC edge banding.

Hardware

- Telescopic channels.
- Soft close hinges.
- Locks for drawers/storage.
- SS handles.
- Cable managers wherever required.

Polish & Finishing

- All exposed edges shall be edge-banded.
- Sharp edges shall not be permitted.
- Proper alignment and level finishing mandatory.

6. STANDARD DESK SPECIFICATION

All standard staff desks shall generally consist of:

- Height: 3'-0"
- 2 Drawers
- 1 Vertical Storage Section
- Keyboard provision wherever required
- Wire management provision
- Side modesty panel

Approximate desk size:

- 4'-0" x 2'-6" for staff desks
- 5'-0" to 6'-0" for cabin desks

7. TENDER ELIGIBILITY CRITERIA

The bidder shall fulfill the following criteria:

- Minimum 5 years' experience in modular furniture / interior works.
- Experience in office/ bank/ commercial furniture projects.
- Valid GST registration.
- PAN card copy.
- Adequate workshop and manpower.
- The contractor should not be blacklisted.

8. EARNEST MONEY DEPOSIT (EMD)

- EMD Amount: Rs. 21,000.00
- Tender Fee: Rs. 1,000.00 (Non-Refundable)
- EMD shall be submitted by Demand Draft / Bank Transfer in favour of:

- EMD of successful bidder shall be adjusted against security deposit.

9. SECURITY DEPOSIT

- Security Deposit shall be 5% of contract value.
- Retention may be deducted from running / final bills.
- Security Deposit shall be released after defect liability period.

10. DEFECT LIABILITY PERIOD

Defect Liability Period shall be 12 months from date of completion.

Any manufacturing defects, laminate peeling, hardware failures, misalignment, or workmanship defects shall be rectified by contractor at own cost.

11. TIME OF COMPLETION

The work shall be completed within:

30 Calendar Days from the date of issue of Work Order.

12. PAYMENT TERMS

- Advance payment shall not be made unless specifically approved.
- Running/final bills may be submitted based on progressive completion.
- Measurements and quantities shall be jointly verified.
- Applicable statutory deductions shall be made.
- GST shall be paid extra as applicable.

13. QUALITY REQUIREMENTS

- All materials shall be brand new and unused.
- Furniture shall be free from warping, bending, cracks, or defects.
- Laminate joints and edge finishing shall be neat.
- All hardware shall be properly fixed and aligned.
- Samples may be asked before approval.

14. SAFETY & SITE CONDITIONS

- Contractor shall ensure safe handling and installation.
- Existing bank property shall not be damaged.
- Site cleanliness shall be maintained.
- Labour behaviour and discipline shall be maintained within bank premises.
